#### Audible, Visual, and Tactile Alerts

Three different types of alerts on both the KDC and host device let users know they have come too close and need to adjust: an audible beep, on-screen warning notification, and vibration. The combination of alerts is ideal for accessibility and loud or low visibility work environments.

#### **Adjustable Settings**

To account for changes in social distance recommendations, we've enabled the adjustment of the social distance range per device.

Set the range from 3.3' to 32.8' (1 m to 10 m) with a quick adjustment on the KDC.

#### **Quick and Easy to Deploy**

A simple firmware upgrade is all that's required to enable social distance proximity settings and alerts on all BLE 5.0 KDC devices. If your company has a Bluetooth classic KDC, we are happy to exchange for a BLE device to help ensure the safety of your workforce.

#### **Works with All Operating Systems**








BLE KDCs for barcode and RFID reading are available for use with Android and iOS mobile devices as well as Mac and Windows PCs. The KOAMTAC social distancing feature works with your existing technology - whatever it may be. The reliance on Bluetooth Low Energy means no additional infrastructure is needed - just connect the KDC to the host device and safety is secured.

#### **Automated Employee Contact Tracing**

When users receive proximity alerts, the connected host device also receives the information for comprehensive contact tracing. Managers can use this information to ensure workers maintain social distance and identify increased risk of exposure.
